# Decision of 99<sup>th</sup> CC (10<sup>th</sup> & 11<sup>th</sup> June, 2016) regarding approval of pharmacy institutions

\* Consideration of the approval of Diploma / Degree / Pharm.D / Pharm.D (Post Baccalaureate) course and examination in pharmacy at the undermentioned institutions

It was decided to grant approval for conduct / extension of approval / u/s 12 of the Pharmacy Act, 1948 of Diploma / Degree / Pharm.D / Pharm.D (Post Baccalaureate) course and examination in pharmacy subject to the following conditions -

- a) the institution shall submit SIF every year as per the Time-Schedule prescribed by the Council.
- b) the institution shall submit annual affiliation fee on or before due date.
- c) the institution shall appoint the teaching faculty with the qualification and experience as prescribed under the "Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014".
