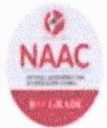
Problems encountered:

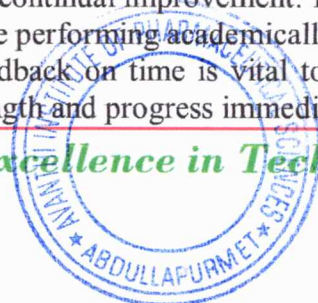
The context:

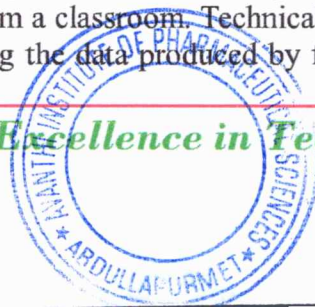
Evidence of Success:

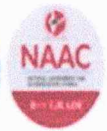
Problems encountered and resources required:
