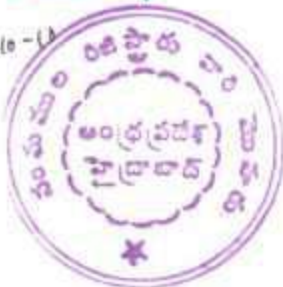

9. Powers of the General Body

They forfeit the membership if they fail to pay the membership fee before the end of financial year, if they fail to attend the general body meeting consequently three times.

55% of the total Members must present to conduct the general body meeting.

The General Body is the supreme authority of the Society and adopt policies resolves the issues and her decisions are final.

The general body has authority to review the actions of the Governing Body and give directions.
